Generally speaking, you don't record these invoices in your accounts receivables because they're usually used for quotes, so the numbers aren't permanent.Ship and track parcels with DHL Express. A pro forma invoice is not issued by the seller until the seller and buyer have agreed to the terms of the order. In a few cases, a pro forma invoice is issued to request advance payments from the buyer, either to allow production to start or for security of the goods produced.A Commercial Invoice is used to record accounts receivable for the seller and accounts payable for the buyer. The content of the Commercial Invoice is almost always the same as the Pro Forma Invoice. If it is a commercial transaction you must indicate correct value of content. You can not "avoid" paying taxes as it is a commercial transaction.
